

(Progress on Matters Subject to Disclosure) Notice of Completion of Business Transfers Between Overseas Subsidiaries and Absorption-Type Merger for Reorganization of European Subsidiaries, and Changes in Trade Names

Regarding reorganization of our European subsidiaries announced in the "Notice of Business Transfers Between Overseas Subsidiaries and Reorganization of European Subsidiaries through an Absorption-Type Merger" as of February 6, 2020, our company completed the procedures for business transfers between overseas subsidiaries and for an absorption-type merger of Mitsubishi Caterpillar Forklift Europe B.V., a subsidiary of MLE (a subsubsidiary of our company), by Mitsubishi Logisnext Europe B.V., a subsidiary of our company (hereinafter referred to as "MLE") on April 1, 2020. Accordingly, it was decided to change the trade names of three production base companies in Europe that are MLE's subsidiaries (sub-subsidiaries of our company)— Rocla Oy, UniCarriers Europe A.B., and UniCarriers Manufacturing SPAIN S.A. to Mitsubishi Logisnext Europe Oy, Mitsubishi Logisnext Europe A.B., and Mitsubishi Logisnext Europe S.A. respectively—to create a sense of unity in European business operations and communicate to the market that they are a part of Mitsubishi Logisnext by adding the group's name to theirs.
