Proposal: Partial Amendment to the Articles of Incorporation

1. Reasons for amendment

The Company resolved the conclusion of an Absorption-type company split Agreement with UniCarriers Corporation, its consolidated subsidiary (hereinafter called "UniCarriers") for which October 1, 2017 (planned) was set as the effective date, at the Board of Directors meeting held on July 13, 2017, in order to integrate business operations between the Company and UniCarriers by the Company's succeeding the businesses of UniCarriers except for its domestic selling business by means of simplified/short-form absorption-type company split (hereinafter called the "Company Split") and the relevant agreement was concluded on the same day.

For that end, it is proposed that the Company's trade name be changed to "Mitsubishi Logisnext Co., Ltd." with the integration of business operations by the Company Split, in order for the whole group to secure further break-through and development as a next-generation player, "Logistical Equipment & System Solutions Next", and as a corporation group contributing to future global society beyond the traditional framework.

The amendment of the Articles of Incorporation shall take effect on the effective date of the Company Split (October 1, 2017), provided that the Company Split takes effect.
